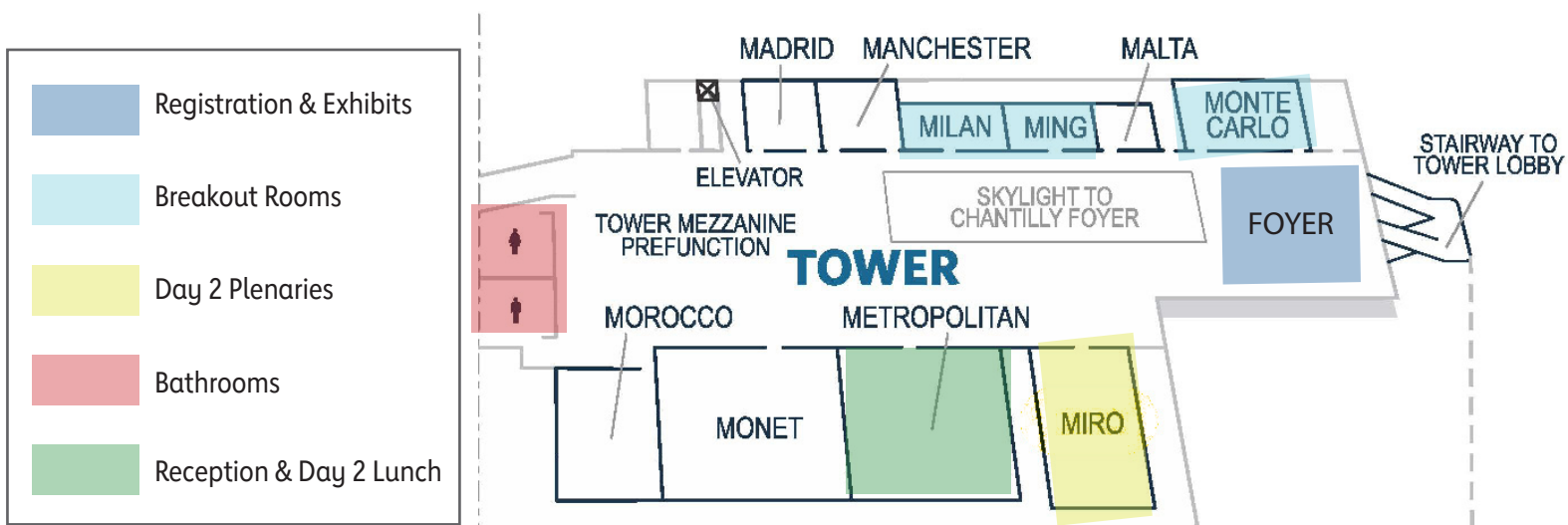

She currently serves as a chair of AHA's ESP committee, member of Get With The Guidelines-Resuscitation's Clinical Work Group, co-chair of the BLS Task Force for ILCOR, member of the Leadership Committee of AHA's Council on Cardiovascular and Stroke Nursing, and member of AHA's Science and Clinical Education Lifelong Learning (SCILL) Committee.

Jane G. Wigginton, MD, MSCS

Dr. Jane G.
