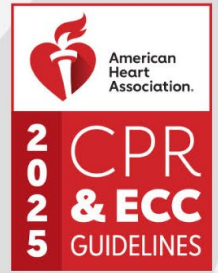

## BLS Provider Instructor-Led Training (ILT) Course Questions

Q: What is the American Heart Association's 2025 BLS Provider Course?

A: The Association's BLS Provider Course trains participants to promptly recognize and respond to several life-threatening emergencies, perform high-quality CPR, and provide early use of an AED. The 2025 course has been updated to reflect new science in the 2025 American Heart Association Guidelines for CPR and ECC. The BLS Provider Course teaches rescue techniques for adults, children (1 year to puberty), and infants (younger than 1 year, excluding the newly born).

Q: What specifically is taught in the new BLS Course?

A: In the 2025 BLS Provider Course, students will learn and practice

- High Quality BLS for adults, children, and infants
- Chest compressions
- Use of an AED
- Effective breaths and ventilation
- Relief of foreign-body airway obstruction for adults, children, and infants
- High Performance Teams

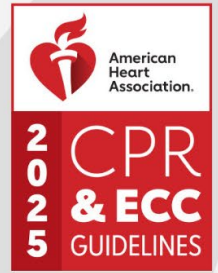
Q: What are the key differences between the 2020 Guidelines and 2025 Guidelines versions of the BLS Provider Course?

A: The new BLS Course includes the following changes:

### *Course Videos*

- All course videos have been updated to reflect the 2025 updates to science and education
- Live-action scenarios in both in and out-of-hospital settings
- Scenarios depicting female cardiac arrest

## *Instructor Manual*

- Instructor-led student practice activities within lesson plans
- New Instructor-led discussions to reinforce video learning
- Lesson plans enhanced with correlating references to the student manual
- It is recommended that Instructors play the practice-while-watching videos once through before having students practice.

## *Skills Testing*

- Inclusion of bystander hands-only CPR in out-of-hospital skills testing scenario
- For the Infant CPR Skills Testing Checklist, students will be tested on both heel of 1 hand and 2 thumb-encircling hands techniques for infant compressions.

## *Provider Manual*

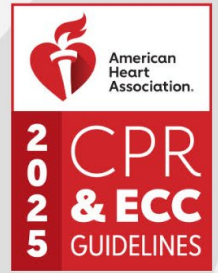
- Updated Chain of Survival
- New science-aligned algorithms
- Updated severe Foreign-Body Airway Obstruction protocols
- Infant compression techniques including both the heel of 1 hand and 2-thumb-encircling hands techniques
- New and revised illustrations

**Q:** What are the course completion requirements for the BLS Provider Course?

**A:** To successfully complete this course and earn your BLS course completion card, students must do the following:

- Participate in hands-on interactive demonstrations of high-quality CPR skills
- Pass the Adult CPR and AED Skills Test
- Pass the Infant CPR Skills Test
- Score at least 84% on the exam

Q: Is there a BLS Renewal Course?

A: Yes.

## BLS Target Audience

Q: Who is the intended audience for the BLS Provider Course?

A: The Association's BLS Provider Course is designed for healthcare professionals and trained first responders who provide care to patients in a wide variety of settings, as well as individuals enrolled in healthcare training programs.

There are still 2 main course tracks for the BLS audience: in-hospital and out-of-hospital. Both tracks include the same course content, but scenarios are tailored to the audience taking the BLS course

Q: What does the term "in-hospital" mean?

A: In-hospital refers to anyone who works or volunteers in a hospital setting.

Q: What does the term "out-of-hospital" mean?

A: Out-of-hospital refers to anyone who works or volunteers outside of the hospital. This was previously called the prehospital track.

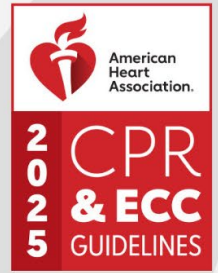

A: Approximate times for each version of the BLS Provider Course are listed below:

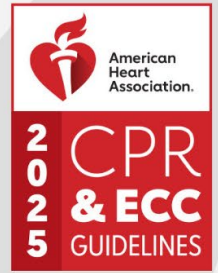
- BLS ILT Full Course: 4:30 hours with breaks

## 2025 BLS Instructor Update (25-1637)

The 2025 American Heart Association Guidelines BLS Instructor Update Course provides Association Instructors updates on new science and key changes published in the 2025 Guidelines for CPR and ECC. They also deliver Interim Training Materials and guidance on how to use these materials to incorporate 2025 science and education updates. All US Association Instructors must complete their required science update by 11:59 p.m. February 28, 2026, to continue teaching Association courses.

## 2025 BLS Product & Course Orientation (KJ-1888)

The P&CO provides BLS Instructors

- Information about new course materials, course curriculum updates, and how the changes impact the way you will teach the BLS Course
- Details, clarification, and direction on various course formats
- Specifics about new BLS course materials
- Steps to incorporate new updates into various course settings

While all BLS Instructors are strongly encouraged to complete the P&CO before teaching the new course, it is not required. Viewing the P&CO is most helpful if Instructors have new course materials in hand while viewing.

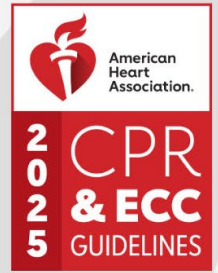

## 2025 BLS Exam

**Q:** Are students allowed to access resources when taking the BLS Provider Course Exam?

**A:** The Association has adopted an open-resource policy for exams. Open resource means that students may use resources as a reference while completing the exam.

Resources could include the provider manual, either in printed form or as an eBook on personal devices, any notes the student took during the provider course, the 2025 Handbook of ECC for Healthcare Providers, the 2025 American Heart Association Guidelines for CPR and ECC, posters, etc. Open resource does not mean open discussion with other students or the Instructor. Students may not interact with each other during the exam.

A: A print version of the Spanish BLS provider manual is expected to become available late summer. Please stay tuned for more information in upcoming communications.

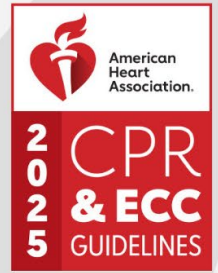
Q: Will classes be available in Spanish through Atlas?
